Greetings from Colebrook Town Hall.

To encourage compliance with posted speed limits in Town, next week we will take possession of two additional solar-powered speed monitors, similar to those currently in use on Route 183 adjacent to Colebrook Center.

Later this month, following DOT approval, these monitors will be installed by our Department of Public Works (DPW) crew on Route 8 in Colebrook, where the speed limit is 40 MPH. The signs will be on loan to the Town for two months, from the traffic center at the University of Connecticut. We intend to apply for a Federal grant to purchase monitors for permanent placement in 2025.

Early voting is available next week at Colebrook Town Hall for the Connecticut U.S. Senate Republican Primary. Hours are Monday, Wednesday, Friday, Saturday and Sunday from 10 a.m-6 p.m., and Tuesday and Thursday from 8 a.m.-8 p.m., in the upstairs meeting room at Town Hall. During August, our DPW crew will be supporting the early stages of the HVAC project at Colebrook Consolidated School by digging trenches for the power and fuel lines.

The Colebrook Conservation Commission reports that wild parsnip, an invasive weed, is now setting seeds—and each plant can produce hundreds. Commission Chair Joyce Hemingson advises cutting the seedheads off and keep them in a black plastic bag for at least a week in the sun before disposing in the trash.

When working with wild parsnip, wear long sleeves, pants and gloves as a precaution. If you get sap from the leaves on your skin, and it's exposed to sunlight, it causes a chemical burn that can take a while to go away. If you come into contact with the sap, wash the area thoroughly with soap and water. Learn more here, and <a href=here.
