Old Business

Pisgah Mountain Road — Brad said the Board of Selectmen's goal is to keep the road maintained as a scenic road. The road is closed now and will continue to be closed for the winter. Brad said there will be an informational town meeting in the winter to discuss Pisgah Mountain Road. Duncan shared the "T2" Request for Technical Assistance Field review report dated May 29, 2022 from the CT Transportation Institute (see attached). There was a discussion of who has authority over the road. Duncan cited 1989 Colebrook Scenic Road town ordinance (see attached) and said the town should maintain "right of way" for this road as it is an historic road. He made suggestions about rock material cover and possible cost estimation to implement. Edna informed all with a history of the road.

Pollinator Garden — Joyce talked to Sally Root about working on it. Edna will cut back stems.

Cooper Trail — Edna, Kim and Mike will walk the trail to assess maintenance needs.

Colebrook Fair recap —The photo contest was a big draw and great talking point to many who stopped by the booth.
