As noted last week, due to severe drought conditions, ALL open burning in Colebrook is strictly prohibited until further notice. This includes ALL leaf burning, and the use of fire pits and chimineas, without exception. Please exercise extreme caution, especially when disposing of smoking materials outdoors.

Town Hall will be closed on Monday, November 11<sup>th</sup>, for Veterans Day. **Curbside trash and recycling** pickup will run on a regular schedule next week.

Thank you to our poll workers, our Registrars of Voters and our Town Clerk and Assistant Town Clerk for their tireless efforts—and a very smooth early voting and Election Day.

Last week, the Boards of Selectmen and Finance voted to send a proposed 20-year, \$4.9 million Tax Stabilization Agreement with Wind Colebrook South (WCS) to a Town-wide referendum during December, with the date to be finalized. Wind Colebrook South owns and operates the wind turbine facility on 17 and 29 Flagg Hill Road in Colebrook.

A Tax Stabilization Agreement would end WCS's nine-year tax appeal which went to trial again in May of this year—and two other tax appeals WCS had filed for subsequent tax years. As noted earlier, negotiations between the Town and WCS in July resulted in WCS making several concessions to the Town which they had previously refused to make. Since then, the Town Attorney has worked with us to negotiate agreement language. The Town will host a Public Informational Hearing prior to the referendum to enable residents to ask questions and learn more. Details to come.

The Post Office drainage/paving project is almost complete. Striping will take place tomorrow. Parking will be limited.
