This month, the Board of Selectmen is reaching out to all Town boards and Commissions to kick off the 2025/26 budget process. We'll provide updates as we move closer to our annual budget referendum in May.

During the winter months, the Department of Public Works strives to keep our 40 miles of Town roadways passable (with the State responsible for Routes182, 182A and 183). Please adhere to the following requests to ensure the roads are cleared safely and efficiently:

- Move all vehicles from the street.
- Don't blow or shovel snow into the street, especially after it has been plowed.
- Shovel your driveway apron after your street has been plowed.
- Don't try to pass a plow or salt truck—and maintain a safe distance behind.
- Roads are plowed in a prescribed order. Each of our 4 drivers are responsible for 20-miles of roads (60-90 minutes in duration). They will get to your street as quickly as possible.

Also, in the near-term, we are slightly shorthanded, utilizing a three-man crew for plowing/salting. This will be until our newest team member completes the certification process for his CDL license, anticipated in the next few weeks.
