Greetings from Colebrook Town Hall.

The Capital Improvement Program (CIP) Committee is developing recommendations for our fiscal year 2025/26 capital budget. The CIP committee is comprised of representatives from the Board of Education, Board of Finance, Board of Selectmen, the Fire Department and a representative from the public-at-large. Municipal capital items are assets intended to benefit the community for more than a single fiscal year.

The 2024-2025 fiscal year capital budget of \$380,000 includes: improvements for Colebrook Consolidated School (including funds toward our new HVAC system for the school); gear for the Colebrook Fire Department, and matching funds for gear washing equipment; matching funds for grant-funded paving projects; and money set aside toward the purchase of our next Community & Senior Center van, and Department of Public Works snowplow truck.

The Town is preparing its annual application for a Small Town Economic Assistance Program grant from the State, which helps to fund paving projects, matched by our capital budget. On this year's list, we are requesting funds for paving of the Colebrook Fire Department Center House parking lot and sections of Deer Hill, Gaylord, Phelps and Millbrook Roads.

To maximize interest income on Town funds, we routinely sweep monies into the State Treasurer's Short-Term Investment Fund, a Standard & Poor's AAAm rated investment pool of high-quality, short term money market instruments managed by the Cash Management Division of the Office of the State Treasurer. Through the first half of the current fiscal year, interest earned by the Town was approximately \$88,000, roughly \$40,000 ahead of mid-year last year, which complements our tax revenues.

As noted recently, real estate taxes are due. To avoid penalty, payment must be made by Monday, February 3<sup>rd</sup>, 2025.
